### APPLICABILITY:

This privacy policy (“Policy”) describes our policies and procedures on the collection, use, storage and disclosure of any information including, business or personal information provided by you while using Our Website.

### COLLECTION OF INFORMATION:

Edu-versity will use the information provided by you only in accordance with the purposes described in the Policy. During your use of our website, we may collect and process such information from you, including but not limited to the below mentioned:

Information that you provide to us by filling in forms on the Website. This includes contact information such as name, email address, mailing address, phone number, any financial information, if any, unique identifiers such as user name, account number and password.

Information that you provide when you write directly to us (including by e-mail).

Information that you provide to us over telephone. We may make and keep a record of the information you share with us; Information that you provide to us by completing surveys.

When you use the Website, Our servers automatically record certain information that your web browser sends whenever you visit any website. These server logs may include information such as your web request, Internet Protocol (IP) address, browser type, referring/ exit pages and URLs, number of clicks, domain names, landing pages, pages viewed, and other such information.
